(A) Notes to the interim financial statements

1) Basis of preparation

Tekala Corporation Berhad is a public limited liability company incorporated and domiciled in Malaysia, and is listed on Bursa Malaysia Securities Berhad.

These unaudited condensed consolidated interim financial statements, for the period ended 30 September 2015, have been prepared in accordance with MFRS 134 *Interim Financial Reporting* issued by the Malaysian Accounting Standards Board and paragraph 9.22 of the Listing Requirements of Bursa Malaysia Securities Berhad. These unaudited condensed consolidated interim financial statements also comply with IAS 34 Interim Financial Reporting issued by the International Accounting Standards Board.

The interim financial report should be read in conjunction with the audited financial statements for the year ended 31 March 2015. These explanatory notes attached to the interim financial report provide an explanation of events and transactions that are significant to an understanding of the changes in the financial position and performance of the Group since the year ended 31 March 2015.

2) Accounting Policies

The accounting policies and presentation adopted for the interim financial reporting are consistent with those adopted for the audited financial statements for the year ended 31 March 2015.

3) Seasonality of operations

The Group's operations are not seasonal and cyclical in nature.

(B) Additional information required by Bursa Malaysia Securities Berhad's Listing Requirements

1. Performance review

For the current quarter ended 30 September 2015, the Group recorded a revenue of RM7.80 million as compared to the previous corresponding quarter of RM13.03 million and a loss before tax of RM3.82 million as compared to loss before tax of RM3.89 million in the previous corresponding quarter.

For the current period ended 30 September 2015, the Group recorded a revenue of RM15.01 million as compared to the previous corresponding period of RM28.40 million and a loss before tax of RM7.18 million as compared to loss before tax of RM5.82 million in the previous corresponding period.

The lower revenue and loss before tax for the current quarter and period as compared to the previous corresponding quarter and period were mainly due to lower plywood sales and high log costs for the current quarter and period under review.

2. Comments on material changes in profit before taxation

The Group loss before tax of RM3.82 million for the current quarter was slightly higher mainly due to other expenses as compared to the immediate preceding quarter loss before tax of RM3.36 million.

3. Commentary on Prospects

Barring any unforeseen circumstances, the Directors expect the Group's plywood operations for the current financial year to be difficult.

4. Profits forecast and profit guarantee

The above is not applicable as no profit forecast and profit guarantee were provided.
